

This Memorandum Of Understanding is made on....., between, Managing Director, Karnataka Rural Infrastructure Development Limited, 4th Floor, Grameenabhivruddhi Bhavana, Anand Rao Circle, Bengaluru – 560009 (hereinafter called the Client) on the one hand and, on the other hand,, represented by, having its location at(hereinafter called the "Engineering Colleges/ Technical Institutions").

WHEREAS

1. KRIDL had invited for the Empanelment for providing Third Party Inspection, Quality Assurance and Quality Control (QA & QC) services for works of KRIDL vide Notification: KRIDL/WKS/Emp/TPI/2021-22 Date: 27/08/2021.
2. KRIDL has accepted the application of vide Office letter no. KRIDL/WKS/EOI/ TND/2021-22, Dated: 04.11.2021 and empanelled for providing Third Party Inspection, Quality Assurance and Quality Control (QA & QC) services for works of KRIDL.
3. It is made clear and binding on both the parties that the services of Third Party Inspection, Quality Assurance and Quality Control (QA & QC) shall commence from the 1st Stage as mentioned in the Terms of Reference (TOR)
4. KRIDL has informed and made known to the Consultant that the time is the essence of this agreement and the Consultant has agreed to take up the work on the terms and conditions set out hereunder;
5. A fixed offer of services charges of 0.5% of the SR Amount of the Estimate will be the cost of Third Party Inspection, Quality Assurance and Monitoring for the works of KRIDL.

NOW THEREFORE Empanelled Engineering Colleges/ Technical Institution agree as follows:

1. The job of Third Party inspection and quality assurance during and after completion shall be combination of field visits, testing of materials, and comments on construction.
2. The empanelment Time period is 2 (two) years.
3. The selected Empanelled Engineering Colleges/ Technical Institution will be fully and completely responsible to the KRIDL for all the deliverables agreed as mentioned in the contract
4. KRIDL requires that the Engineering Colleges/ Technical Institution should provide professional, objective, and impartial advice and at all times hold the interest of the KRIDL paramount, strictly avoid conflicts with other assignments/jobs or their own interests and act without any consideration for future work.
5. In case any of the proposed Engineering Colleges/ Technical Institution are found to be not performing or not meeting the expectations of the department, the KRIDL

shall have a right to find a replacement for the Engineering Colleges/ Technical Institution.

6. The KRIDL reserve the right to terminate the contract by giving a notice of one month if the performance of the evaluator is not found satisfactory.
7. All other conditions of Empanelment as per the Objectives and Description of Empanelment document (Page 1- 15) holds good.
