NOTE \* Initially the services of Sri.N. Srinivasa Reddy was regularized as AE Gr-1 vide OM dated 27-05-1987 giving effect from 17-12-1984 & his rank is fixed between SI.No.40 Sri.S.G. Bulla and SI.No.41 Sri.K.V. Mallesh & his rank was given at SI.No.40a. Later one more OM was issued on 09-03-1994 by fixing the Seniority between Sri.S.K. Kolhar & Sri.T. Ravi (in between SI.No.9 & 10) to provisional Seniority List of AEs as on on 31-03-1991. Thereafter vide OM dated 01-08-2001, the earlier order issued on 27-05-1987 & 09-03-1994 have been withdrawn. Against this Sri.N. Srinivasa Reedy has filled a W.P. before the Hon'ble High Court of Karnataka in 41212 / 2001. The Hon/ble High Court in its order dated 13-02-2001 has stayed the OM dt.01-08-2001.

The W.P.No.41212/2001 was disposed of by an order dated 10-04-2015 making it subject to the result of the writ appeal No.15216/2011 filed against the order dated 13-07-2011. A Review Petition was filed by him in R.P.No.200058/2015 against the order dated 10-04-2015 on the ground that the petitioner was not heard in the matter. The said review petition came to be rejected on 17-04-2017. Being aggrieved by the order dated 10-04-2015 passed in W.P.No.41212/2001 and order dated 06-10-2015 passed in R.P.No.200058/2015, he has filed Writ Appeal No.4191/2017 before the Division Bench of High Court at Bangalore. Hence his Seniority is fixed is subject to outcome in W.A. No.4191/2017.
