In this regard supply orders for supply of TMT Steel Bars as per IS 1786 shall be placed on the approved firm, namely M/s. Rashmi Metaliks Ltd., as per requirement of the project. Please ensure that minimum one truck load of steel quantity of 10 MT supply order shall be placed against approved firms.

The approved rates towards supply of steel by the firm is inclusive of all taxes, transportation, loading and unloading FOR to KRIDL Projects. Validity of rates is from date : 01/03/2014 to 30/08/2014.

- ❖ The supply of Steel shall be as per standard specification Fe 500 IS 1786, Test Certificate of steel shall be obtained for each consignment.
- ❖ Tender documents and rate list are uploaded in the KRIDL website [www.kridl.gov.in](http://www.kridl.gov.in) for delay in supply and discrepancies if any in supply of steel bars action shall be initiated by concerned Deputy Director, KRIDL, as per terms and conditions of tender.
- ❖ The Payment towards Supply of TMT Steel Bars to the firms shall be made against supply immediately as per norms.
- ❖ Random sample shall be got tested in the supplied quantity from reputed Laboratories/Local Engineering Colleges at regular intervals for reference and records.
- ❖ Copy of supply orders placed by the project and bills/invoices received against supplies shall be marked to Hqrs. for reference and record.
- ❖ The details of quantities received and payments made shall be accounted in the stores account and ledgers as per KRIDL procedure and norms.
