#### 1. KARNATAKA RURAL INFRASTRUCTURE DEVELOPMENT LTD

Karnataka Rural Infrastructure Development Limited the Company is a Govt. of Karnataka undertaking, was started as a Directorate of Land army in the year 1971 under the Department of Rural Development and co-operation of Government of Karnataka. It was incorporated as a company under the Companies Act 1956 on the 9th August 1974 as Karnataka Land Army Corporation Limited under the full and complete ownership of Government of Karnataka.

It was renamed as Karnataka Rural Infrastructure Development Limited on 6th August 2008 and it is a designated agency of Govt. of Karnataka involved in the Civil Engineering construction and creation of assets in the state of Karnataka.

The Head Quarters of KRIDL is at Bangalore with Zones, Divisions and Sub divisions functioning all over the state.

#### 1.1 OBJECTIVES OF KRIDL

Objective of KRIDL is to concentrate labour intensive infrastructure works which are vital for development by providing employment opportunities to rural unemployed and under employed to improve their economic conditions.

To undertake all development construction works directly by eliminating middlemen, i.e., contractors, to avoid exploitation, thereby passing on the full worth of money to the people.

KRIDL takes up the work of construction of Minor irrigation tanks, Lift irrigation scheme, Hostel, Hospitals, Go downs, Bus depot, Yathri Nivas, Water supply, Stadium etc., there by working all over development in the state.

During the course of execution of works, by imparting training to the masons and carpenters/Barbendors etc., the confidence level is expected to be built up among themselves for their livelihood.

#### 1.4 TECHNICAL WORKING STRENGTH

KRIDL has established its working network over the entire length and breadth of Karnataka and also outside. Equipped to execute any magnitude and any nature of civil works with a working force of 975, which includes 350 highly qualified Civil Engineers.

#### 1.5 PROJECTS

KRIDL builds infrastructure relating to Development Programmes, like Communication, Bridges, Buildings like Residential School Complexes, School buildings, Office complexes, Shopping complexes, Tourism department works, Hospitals, Hostels, Houses, Consumer Forum, Youth Services, Navodaya Vidhyalaya Sangatan (NVS), Kendriya Vidhyalaya Sangatan (KVS), Integrated Area Development, Water Resource Development, Dairy, Fisheries, Minor Irrigation, Providing Consultancy Services, Other developmental projects. KRIDL is executing over 3500 projects all over the state.

#### 1.6 IMPORTANT SCHEMES UNDERTAKEN BY THE COMPANY

The KRIDL has executed works mainly under the following schemes entrusted by the Government Departments and other local bodies during the year.

- a) **Suvarna Grama Yojane:** The Government has been entrusting works to KRIDL under this scheme from phase I itself. At present phase IV is yet to be started. The Company has received works of Rs.167.41 crores during the year as against Rs.58.98 crores received during 2009-10 for different phases.
- b) **Social Welfare Department Works:** Social Welfare Department is entrusting the construction of Hostels at various places in the State. During 2010-11, the Department has entrusted 67 number of Hostels at an estimated cost of Rs.55.81 crores as against 60 number of works entrusted at an estimated cost of Rs.51.02 crores in the previous year. The Department has also entrusted additional constructions and repairs to the existing buildings at an estimated cost of Rs.25.49 crores during the year.



- c) **Grama Panchayath Buildings:** The Government has taken up the construction of Buildings to the Grama Panchayathies with the assistance of NABARD. The Zilla Panchayaths of various districts have entrusted the construction of 455 number of Grama Panchayath Buildings located in 152 Taluks under three phases. The estimated cost of these buildings is Rs.75.57 crores and 172 Buildings have been completed and remaining are in different stage of completion.
- d) **BBMP Works:** Bruhat Bangalore Mahanagara Palike has entrusted various works such as widening and asphalting of Roads, construction of Drainages, construction of low cost houses, Samudaya Bhavanas, Toilets, Bus Terminals etc. During the year BBMP has entrusted works to the extent of Rs.250.00 crores. Company has completed works to the extent of Rs.82.00 crores during the year.
- e) **Asare Houses:** The Government has entrusted the construction of 11,049 houses in 10 district located in 97 places for the floor affected people in northern Karnataka at an estimated cost of Rs.150.31 crores. Out of this, Company has taken up construction of 9844 houses in 88 places for which sites were given by the local authority. Government has released Rs.140.00 crores for construction of these houses. The Company has completed 8577 houses in 76 places and the remaining houses are in different stage of completion.

**Other works:** The Company is also getting works from Tourism, Fisheries, Forest, Horticulture Departments and other Government agencies and local bodies. MLAs and MPs are also entrusting works from their developments funds.

#### 1.7 PARTICIPATION IN TENDER/GENERATION OF REVENUE TO ORGANIZATION

Works were entrusted directly to KRIDL for execution by the Government Departments and others till 1999-2000.

Management of KRIDL felt due to implementation of Transparency Act 2000 in Karnataka, entrustment works to KRIDL has reduced considerably. In order to generate more work and earn revenue and to meet the overhead charges, it is necessary for KRIDL to diversify its activities. The subject was discussed at length by the Board of Directors and it was resolved that KRIDL shall participate in tender/subletting and enter into joint venture with other agencies.

Hence it is resolved to empanel Contractors/Firms/Company in KRIDL to facilitate it to diversify the activities, and generate new works on joint venture basis. Participation of the Company in tender with empanelled contractors to



work on back to back payment systems etc., and subletting of contracts which will benefit the company in generating additional revenue apart from execution of works by KRIDL.

In the 170th Board meeting held on 13.07.2012, it was resolved and approved to participate in tenders by authorizing Contractors/Firms/ companies on behalf of KRIDL with a conditions that Contractors / Firms / companies shall remit necessary EMD and will bear the other Financial Implications and KRIDL shall be entitled to agency charges of certain percentages as mutually agreed to by both the parties. Approved Contractors/Firms/companies shall enter into agreement with KRIDL and also provide Bank guarantee to the value of 20% of the work.

KRIDL has resolved to empanel the Contractors/Firms/companies in four categories as below.

- a) Category A Up to 500 lakhs
- b) Category B 501 to 1000 lakhs
- c) Category C 1001 to 5000 lakhs
- d) Category D 5001 to and above

#### 1.8 METHODOLOGY AND SELECTION OF AGENCY:

- a) In the first step eligible Contractors/Firms/companies are required to be empanelled in KRIDL to associate in obtaining contracts which will be mutually benefit to both the parties.
- b) Empanelled Contractors/Firms/companies are required to quote the percentage of sharing with KRIDL in the e-portal so as to finalise the agency and issue authorization for work proposed for bidding.
- c) The approved Contractors/Firms/Companies shall remit necessary EMD and shall bear all other Financial Implications in respect of tender for which they are authorized by KRIDL.
- d) The approved Contractors/Firms/companies shall enter into an agreement with KRIDL and also provide Bank guarantee to the value of 20% of the work indicated in the bid.

#### 3. Instructions to Applicants

#### 3.1 Scope of Empanelment

KRIDL intends to Empanelment of Contractors/Firms/Companies, for bidding for the Construction of various Civil works such as buildings, Highways, Bridges, Water supply works and Electrification works in Karnataka State and outside Karnataka and other developmental projects exclusively at various locations in the State of Karnataka on turnkey basis. The Empanelment will be valid for a period of five years. The eligible bidders either apply for Empanelment for either category are both categories of works, depending on their experience and capability.

#### 3.2 Submission of completed Empanelment document

All the information requested for Empanelment shall be submitted in English only. Document duly signed shall be uploaded on e-procurement portal in www.eproc.karnataka.gov.in.

Failure to provide the correct information as desired in the prescribed formats appended to this notification to provide timely clarifications or substantiation of the information supplied, may result in disqualification of the applicant/applicant firms.

#### 3.3 General Information and Conditions:

- 3.3.1 Only applicants from India are eligible to apply.
- 3.3.2 The bidder shall submit /register in e-portal for category of works i.e., A, B, C & D based on the eligibility criteria.
  - a) Bidder registering for D category of works is eligible to participate in A, B & C category works also.
  - b) Bidder registering for C category of works is eligible to participate in A & B category works also.
  - c) Bidder registering for B category of works is eligible to participate in A category works also.
- 3.3.3 The Empanelment criteria indicated in Table-1, shall be supported by credentials with regard to work experience, financial capacity, technical capability (inclusive of equipment and staff to be made available for the contract) etc.



- 3.3.4 All financial information submitted with the application, including statements of Net Worth and Value of Current Contract Commitments shall be certified by a Chartered Accountant.
- 3.3.5 An applicant's financial capability will be assessed on the basis of Bank credit facility, turnover/income from contracting, net worth, and the value of the unfinished portion of current contracts/contract commitments.
- 3.3.6 The bid of empanelled Contractors/Firms/companies for any particular package / project will be considered only if the assessed available bid capacity of the applicant is more than the total bid value. The available bid capacity will be calculated as under:
  - A. In case of works costing upto Rs.100.00 lakhs.

Assessed Available Bid capacity = (A\*N\*2.5-B)

B. In case of works costing Rs.100.00 lakhs and above.

Assessed Available Bid capacity = (A\*N\*1.5-B)

#### Where

A=Maximum value of civil Engineering works executed in any one year during the last 5 years (updated to \_\_\_\_\_\_ price level) taking into account the completed as well as works in progress.

N=Number of years prescribed for completion of the works for which tenders were invited.

B=Value, at \_\_\_\_\_ price level, of existing commitments and on-going works to be completed during the next.... Years (period of completion of the works for which Tenders are invited) opened the financial bids will not be considered.

**Note:** The statement showing the value of existing commitments and ongoing works as well as the stipulated period of completion remaining for each of the works listed should be countersigned by the Engineer in charge, not below the rank of an Executive engineer or equivalent.

- 3.3.7 The applicant must possess an adequate number of site personnel, having considerable relevant experience in execution of the works.
- 3.3.8 The Contractors/Firms/companies may open an Office at Bangalore and at the project site in the event of award of contract to them.



- 3.3.9 The duration of completion of work will be as per the tender conditions.
- 3.3.10Each tenderer should further demonstrate availability by owning atleast 50% of the required / specified key and critical equipment for the work and the remaining 50% can be deployed on lease / hire basis for all works provided the relevant documents (commitment / agreement etc.,) for availability of this work are furnished. Further, the average age of the equipment will also be considered in evaluation.

Other parameters such as the structure and organization of the applicant in terms of legal status, adequate structure covering all disciplines, bankers solvency certificate, details of material testing laboratory and litigation history etc., will be given due consideration in evaluation for Empanelment.

- 3.3.11The applicant must not be associated with the Consultant or any other entity that has prepared the designs, specifications and other Empanelment and bidding documents for the proposed works, or he should not have worked as Engineer for the Contract, over the last three years. Any such association may result in disqualification of the Applicant.
- 3.3.12Only Contractors/Firms/companies that have been pre-qualified under this procedure will be invited to bid for the projects by KRIDL.
- 3.3.13Enrolment in the list of selected Contractors/Firms/companies shall not confer the right on the contractor to claim awarding of contract or does not give any guarantee for awarding any work to the applicant.
- 3.3.14Even though the applicant meets all the qualifying criteria, he is subject to be disqualified if he has:
  - Made misleading or false representation in the formats, statements and attachments submitted and or
  - Has demonstrated a record of poor performance such as abandoning works, not properly completing the contract, inordinate delays in completion, litigation history, financial failures, etc.

#### 3.3.15 KRIDL reserves the right to:

- Reject or accept any application; and
- Cancel the Empanelment process & reject all applications.



- 3.3.16KRIDL will neither be liable for any such actions nor be under any obligation to inform the applicant of the grounds of rejection.
- 3.3.17No earnest money is required while submitting the Empanelment document.
- 3.3.18On scrutinizing the empanel document, the successful bidder will be provisionally qualified and bidder will have to remit prescribed registration fee (not refundable) in the form of Demand Draft from Scheduled Bank in favour of Managing Director, KRIDL payable at Bangalore within 15 days from the date of such intimation. - 3.3.19Companies possessing ISO 9000/14,000 certification will be given preference.
- 3.3.20No loss-making Companies will be entertained.
- 3.3.21 The Empanelment will be valid for a period of five years from the date of Empanelment/registration.
- 3.3.22Cost over run and time over run will not be allowed in the project.
- 3.3.23The projects executed by the bidder will be independently evaluated by third party for quality assurance. Third party will be appointed by KRIDL for this purpose. The finding of the third party will be binding on both the parties.
- 3.3.24Individual firms having all the capability will be preferred for a particular project.
- 3.3.25The empanelled contractors/firms/companies shall sign NON DISCLOSURE OF INFORMATION agreement with KRIDL at the time of accepting the letter of empanelment.
- 3.3.26The Empanelled contractors / firms / companies participated through KRIDL for the tender shall not participate in the open bidding process for the same work.


