The Company is involved in execution of construction works engaged Task Force Commanders /Asst. Task Force Commanders who are directly responsible for the actual execution of works under the control of Deputy Directors/ Asst. Directors.

Prior to framing of Cadre & Recruitment Rules, 1996, KLAC Service Rules 1974 was in existence and in that Rules, the designation has been given to various cadres including that of General Managers, Joint Directors, Deputy Directors, Asst. Directors etc., These designation does not reflect the nature of duty carried out by them.

Since the name of the Company has been changed from Karnataka Land Corporation Limited to Karnataka Rural Infrastructure Development Limited and also Office procedure followed in State Government offices is generally followed in KRIDL Hqrs., as well as in the Office of DDs/ ADs. Hence it is felt necessary to change the designation of certain cadres in Group A, B & C namely General Managers, Joint Directors, Deputy Directors, Asst. Directors etc., in line with Public Works Department, PRED, Irrigation Department etc.,

In view of the above, a proposal was placed before the Board of Directors in their 174th Meeting to change designation of certain cadres namely General Managers (Works), Joint Directors (Works), Deputy Directors, Asst.
